

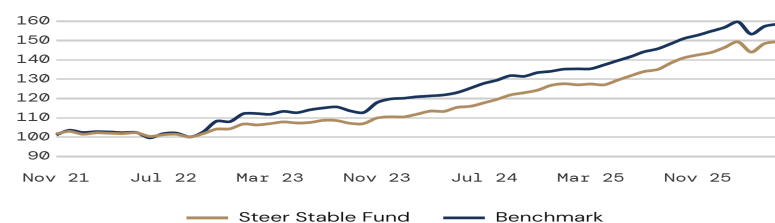
OBJECTIVE

INVESTMENT POLICY

In order to achieve its objective, the investments to be included in the portfolio may comprise a combination of local and global assets in liquid form, equity securities, notes, property securities, preference shares, convertible equities, interest bearing instruments, derivatives and non-equity securities. The portfolio may from time to time invest in listed and unlisted financial instruments, in accordance with the provisions of the Act, and the Regulations thereto, as amended from time to time, in order to achieve the portfolio's investment objective.

RISK PROFILE
